Subject: Road Closure Bylaw



- 1. PURPOSE To finalize the closure process for a portion of 45 Street on the north side of Alix.
- 2. BACKGROUND On January 18, 2023 first reading of Bylaw 476/23 was done by Council. A Public Hearing on the bylaw was held February 15, 2023. A Road Closure package was sent to Alberta Transportation March 8, 2023 for review and approval by the Minister. We have now received confirmation of approval to proceed.
- 3. **OPTIONS** 1. To give second and third readings to bylaw 476/23
 - 2. To give second reading only and table third reading to a future meeting
- 4. **DISCUSSION** This matter has been in the works for nearly a year at this point. The public have had opportunity to provide feedback or register concerns at the Public Hearing this past winter. Delaying third reading of this bylaw would also mean a delay to the Land Use Bylaw amendment necessary to re-zone this piece of land and move forward with the consolidation and sale.
- 5. **FINANCIAL IMPLICATIONS** No financial implications to passing the bylaw, but it is necessary in order to sell the property.
- **6. LEGAL** No further steps could be taken in this process until approval was received from the Minister of Transportation.
- 7. POLITICAL/PUBLIC IMPLICATIONS The adjacent property owners who wish to buy the section of closed road are hoping the matter proceeds as quickly as possible.

1. **PURPOSE** – To determine if Council would like to proceed with planting trees at the perimeter of the cemetery.

2. BACKGROUND – This matter was brought to a Council meeting in June 2022 (RFD attached) and deferred to the fall Strategic Planning meeting. No decision was made at that time regarding how to proceed. This is a sensitive matter as it deals with both the ongoing maintenance of the cemetery and respectfully addressing the wishes of public to honour their loved ones.

Space was left to plant trees on the south border of the cemetery when installing the new cremation ribbons.

- 3. OPTIONS 1. To allow public to purchase memorial trees for planting at the cemetery
 - 2. The Village purchases and plants trees along the south boundary of the Cemetery and makes them available for memorial sponsorship
- 4. **DISCUSSION** If the Village purchases the trees and plants them, we would be able to select trees that are appropriate to the location. Trees would also be more uniform along the property line as they would be planted all at once rather than as we are approached by the public for memorial trees.
- 5. FINANCIAL IMPLICATIONS There is currently \$1,500 in the budget that could be used to purchase trees. If Option #2 is chosen, I recommend a charge for 'sponsorship' of a tree. This could either be an annual charge or a one time fee. I suggest the Village would be responsible for having a plaque made for each sponsored tree that could be attached to the tree by a chain the chain would be loosened as the trunk of the tree grows. Funds for the plaque would come from the 'sponsorship' fee charged.

A plaque on the tree would mean lower maintenance than stakes in the ground or other types of memorial at ground level.

- **6. LEGAL** A policy should be developed if the trees will be made available for memorial purposes.
- 7. POLITICAL/PUBLIC IMPLICATIONS We still get occasional requests from the public regarding memorial trees. We also get comments about how open and exposed the newer area of the cemetery is.
- 8. OTHER COMMENTS There are a limited number of full burial plots available for purchase at this time. We will need to factor in new development (ribbon installation, possibly a survey as well) when discussing Capital Budget needs.
- **9. RECOMMENDATIONS** Option #2. I recommend the following resolution:

Subject: Cemetery Layouts for Cremation Ribbons



- 1. **PURPOSE** To determine how Council would like to develop the open space above the new development of the cremation ribbons at the cemetery.
- 2. BACKGROUND Recently there were additional ribbons placed to increase the amount of cremation plots in the cemetery. There are four ribbons', each having 25 plots. Future cemetery plans include having a total 200 cremation plots in that area. There is a space of approximately 33.5 feet between the existing fence line and the first ribbon. This space was left open for the option of developing Tree Memorial Plantings.
- 3. **OPTIONS** The three layout options are attached to this RDF.
 - 1. To direct administration to move forward with layout option #1, where the Village would leave the open space to be able to plant and maintain trees when the budget allows for the purchase of trees.
 - 2. To direct administration to move forward with layout option #2, where the Village would use the open space for two more ribbons in the future.
 - 3. To direct administration to move forward with layout option #3, where the Village would map out space for Memorial Tree Plantings in the open space along the fence line.
- 4. **DISCUSSION** There are already some trees along the fence line. However, these stop just before the new development of the cremation ribbons. Having the Village planting new trees along this fence line will bring shade, coverage, and privacy to our cemetery, and ensure they are maintained accordingly.

Having the space used for future ribbons to be placed would mean that this section would hold the 200 cremation plots and leave the space to the left open for other development, if necessary. However, this would put the ribbons close to the fence line and the area would remain very open.

Choosing to develop that space into Memorial Tree Plantings would require a new policy, outlining options of what purchasers could plant and how they would be maintained. Having a Memorial Tree area have been requested several times in the past.

5. FINANCIAL IMPLICATIONS – If Option #1 is chosen there would be a cost to the Village to purchase the tree, plant trees and have either staff maintain the trees or incorporate additional tree maintenance into the cemetery maintenance agreement. These expenses would be shared with Lacombe County according to the County's Cemetery Support Policy.

There is an abundance of space that is able to be developed, so condensing to save on area is not of concern to save on money or space.

- 6. LEGAL MGA SECTION 3 states: "The purposes of a municipality are

 (b) to provide services, facilities or other things that, in the opinion of council, are necessary or desirable for all or a part of the municipality,
 - (d) to work collaboratively with neighbouring municipalities to plan, deliver and fund intermunicipal services."
- 7. **POLITICAL/PUBLIC IMPLICATIONS** Those who visit the cemetery like to have it feel more park like having trees also creates a feeling of privacy when visiting loved ones.
- 8. OTHER COMMENTS Once a decision is made by Council, we will be able to go ahead with numbering the new cremation plots so they will be ready for sale. There are only 7 plots left in the Cremation Circle.
- 9. RECOMMENDATIONS Option #1. I recommend the following resolution because it allows for the reduction of red tape that would be created for administration if the other options are chosen;

"That the Village of Alix Council hereby directs administration to move forward with layout option #1, where the Village would leave the open space to be able to plant and maintain trees when the budget allows for the purchase of trees"

- 1. **PURPOSE** To determine how Council would like to proceed with disposal of the above noted Tax Recovery property.
- 2. BACKGROUND 4904 47 Street was transferred to the Village in February, 2022 as a result of the tax recovery process. It went through 2 public auctions and when a real estate agent was contacted to list it for sale, they declined, feeling the property was unsafe for habitation. As per Council resolution, the property was tested for potential remediation and was found to have 2 exterior walls containing asbestos. Public Health also inspected the building and found it non-compliant with Minimum Housing and Health Standards and Alberta Housing Regulations.
- 3. OPTIONS 1. To allow the house to remain on the property and continue to try and sell it
 - 2. To demolish the house and sell the property as a bare lot
- 4. DISCUSSION This is being brought back to Council because demolition and disposal of the house would exceed the reserve bid amount on record. Asbestos was found in the stucco of 2 exterior walls.
- 5. FINANCIAL IMPLICATIONS The reserve bid / price for the property is \$29,500, but the assessed value of the land is \$40,800. The reason for the difference is the home on the property decreases the value of the land. If the home was removed, Council should set a new price for the property based on the most current market value as is required by the MGA.

Financial projection:

Revenue from sale of property \$40,800 **Expenses**: Asbestos remediation \$19,296.60 Demolition, taxes and other expenses \$23,040.24

Project shortfall of \$1,536.84

- 6. LEGAL MGA s 419 "The council must set (a) for each parcel of land to be offered for sale at a public auction, a reserve bid that is as close as reasonably possible to the market value of the parcel"
- 7. POLITICAL/PUBLIC IMPLICATIONS Municipal staff are maintaining the property / grass etc. so it does not become a nuisance to the surrounding home owners.
- 8. OTHER COMMENTS If demolition is not done, the property will need to be boarded up and will remain non-taxable due to municipal ownership. If demolition is done and the property is sold, it would become taxable again.

9. **RECOMMENDATIONS** – Option #2. I recommend Council amends the reserve bid / asking price of the property to the assessed value of the land. If and when the land sells for that amount, most costs owing to the Village will be recovered.

- 1. <u>Council Self Evaluation Forms</u> Everyone will receive a printed copy of the new Self Evaluation tool at the September 6th meeting. Please advise if you would like a closed session added to the next meeting agenda to go over these as a group or if you would prefer to use them strictly for personal / internal reflection.
- 2. <u>CAO Performance Evaluation</u> Sticking with the theme... Councillors will also receive a copy of the CAO Performance Evaluation. This is a legislated requirement through the MGA.
- 3. Lagoon Work is proceeding at the site. Though it was anticipated there would be "soft spots" in cell 6 once the vegetation was removed, it appears the area is significantly larger than anticipated. There was no way anyone could have know how much of the cell was affected until they were down to bare clay. To remediate, contractors must dig down and remove base material, install a non-woven geo-textile material and re-pack dry base material brought in. Everyone is doing their best to keep costs down (including sourcing new base fill from approx. 2 km away) but mitigating this problem is likely to use the entire project contingency funding, possibly more. Contingency funding is \$175,000. Unfortunately there has been a delay to receiving the liner for the cells. As a result of this supply chain issue, we would be looking at late November for liner installation on cell 5. Temperatures at that time of year are not favourable to installing synthetic liner and getting a proper heat seal on liner seams. As a result, the cell 5 portion of this project will not be completed until 2024. It is also anticipated there will be significant 'soft spots' needing mitigation in cell 5. We will not know the extent until the cell is de-watered and the sludge is removed.
- 4. Minimum Tax Levy We will be doing the first of three public information steps about the Minimum Tax Levy coming into effect in 2024. The attached sheet will be sent as a flyer to every Village of Alix mail box. We will also be sending a copy by regular mail to every tax roll that has an address outside of the Village of Alix. Two more engagements will be done (January and March of 2024) before tax notices are sent out.

Minimum Tax Levy will be in effect for the Village of Alix come 2024 tax year



Calculating Minimum Tax Levy

Your municipal taxes will be the greater of the minimum tax or the ad valorem tax calculation. In other words, you will pay either the minimum tax or the ad valorem tax. For example, let's assume that the municipality has implemented a minimum tax of \$400. The mill rate is 10.0 mills, and we have two properties - Property "A" has an assessed value of \$81,700 and Property "B" is assessed at \$13,000.

- Using the ad valorem tax calculation, the municipal tax levy relative to Property "A" is \$81,700 x 10.0 / 1,000 = \$817. As this amount is greater than \$400, the municipal portion of property taxes for Property "A" will be \$817.
- · Using the ad valorem tax calculation, the municipal tax levy relative to Property "B" is \$13,000 x 10.0 / 1,000 = \$130. As this amount is less than \$400, the municipal portion of property taxes for Property "B" will be \$400.

Frequently asked questions:

Q: What is a minimum tax levy?
A: A minimum tax levy may be established by bylaw to increase the amount of taxation revenue generated from lower assessed properties within one or more property classifications. Minimum tax will generally be a specified value or amount; however, it may also be expressed in a formula.

Q: Who will be affected by this?

A: Approximately 8.5% of properties within municipal limits will be affected by the tax levy. Vacant landowners will be most affected.

Q: Can a municipality impose a minimum property tax?

A: Yes. A municipality may set a minimum tax on each property.

The minimum property tax is not a fixed surcharge; it is a tax floor amount. The minimum tax only applies if the calculated tax rate multiplied by the assessed value of the property is lower than the amount set as the minimum tax.

The minimum tax levy for the Village of Alix will be set at \$400. Effective for tax year 2024.



The Village of Alix tax year runs from January to December. Tax/Assessment notices are mailed out in May of each year.

How do they determine my assessment value?

Property assessments are prepared using mass appraisal and reflect a value for July 1 (valuation date) the previous year and a physical condition on December 31 (condition date). Up to 3 years of sales are compiled and adjusted to determine the assessments. Since your property assessment is based on market value, it is affected by market changes caused by supply and demand. The age, size, condition, and improvements done to the property will also affect the assessed value.



As part of the Alberta RCMP's ongoing priority to ensure public safety, encouraging citizens to report all crimes plays a vital role in building community well-being. We recognize that non-urgent crimes such as minor thefts and property crime may go unreported due to various reasons such as perceived insignificance or fear of inconvenience. Thus, the Alberta RCMP continues to engage citizens on the importance of reporting non-urgent crimes to help us optimize our crime prevention efforts.

To help facilitate this, we have made reporting of non-urgent crime easier through the Alberta RCMP APP (available as a free download on the <u>Apple App Store</u> or <u>Google Play</u>). Online crime reporting offers a convenient way for citizens to report non-emergent crime to Alberta RCMP from their computer or smartphone without having to phone or visit the police detachment.

An informed community is a safer community. Here are some reasons why online reporting of non-urgent crimes matters:

- Alberta RCMP police officers in the Call Back Unit are responsible for investigating online crime reports, thus reducing the need for frontline police officers to respond. Encouraging the public to use online crime reporting gives the Detachment frontline officers an opportunity to spend more of their time for proactive policing activities in the community.
- Non-urgent online crime reporting also has the potential to reduce those same nonurgent phone calls to our 911 Operators (OCCS) and Detachment Staff.



The Alberta RCMP encourages citizens to report every crime to allow us to leverage reliable data to identify patterns and trends in criminal activities in our communities. We also use this intelligence to distribute our resources strategically and ensure that our police officers are deployed where they are most needed.



As you are aware, ATCO Gas pays the Village of Alix a franchise fee. The franchise fee is collected from customers in Alix and is based on a percentage of our Delivery Tariff. In Alix, this percentage currently is 12.00%.

In 2022, our Delivery Tariff revenue in Alix was \$293,664. Our forecast Delivery Tariff revenue for 2024 is \$266,603. Therefore, based on the current franchise fee percentage, your forecast 2024 franchise fee revenue would be \$31,992.

Please note that the forecast 2024 Delivery Tariff revenue can be impacted by changes in customer operations and weather. Additionally, ATCO Gas has utilized forecast 2024 delivery rates, however, they are not yet approved by the Alberta Utilities Commission. ATCO Gas commits to providing updated franchise fee revenue forecasts at a future date should there be material impacts related to the update of these forecast assumptions.

Pursuant to our franchise agreement, you have the option to change the franchise fee percentage in 2024. A request to change the franchise fee must be received by ATCO in writing prior to November 1, 2023. If you are considering changing the franchise fee in 2024, please contact us as soon as possible to begin the process.
